## BELLOW ARE STEP BY STEP GUIDE TO OBTAIN A NEW YORK STATE SECURITY GUARD REGISTRATION CARD THROUGH LASI SECURITY GUARD TRAINING SCHOOL,

1. A person must first complete an **8-Hour Pre-assignment Training Course**. This course is required by the New York Department of State Division of Licensing Services to begin the process of obtaining a security guard registration card.
2. You must be scheduled for your fingerprint online. There are several locations for digital fingerprinting! **Please be advised that we do not do fingerprint in our office. We schedule your fingerprint online. You must report to the location scheduled to complete the fingerprint process. Once you have done the fingerprint, you must bring back to our office, one of the two-fingerprint receipts given to you. LASI office will submit to the Department of State Division of Licensing Services, your security guard license application packet with all the necessary documents for processing.**
3. In the application package, there will be a **copy of your 8-Hour Pre-Assignment Training certificate, your fingerprint receipt, your registration application, a check for \$36.00 payable to NYS DOLS, along with any additional document necessary to expedite your application process if required.**
4. **It normally takes about 4-6 weeks to receive your license in the mail.** The security guard registration card is mailed directly to you at the address provided in the license application. Once we mail your license package to the State, we do not have any control over the approval process; neither do we have any control over the delivering of your registration card! If you have any Questions regarding the Status of your application, **you can contact the Department of State directly at (518) 474-7569** during normal business hours. We may also contact the state on your behalf however; you must be present at our office for LASI to reach the state on your behalf.
5. If LASI security did assist in preparing you license application, also submitted the same to the State, we may be able to check the state website portal approximately after **15 business days (THREE WEEKS)** to see if your registration card was approved. If so, we will print a copy for you as proof of your registration approval. With the temporary registration document printed from the state web portal, you may be able to obtain security guard employment pending receipt of the actual card in your mail.
6. **YOUR NEW YORK STATE DMV NON-DRIVER ID OR DRIVER LICENSE MUST HAVE YOUR CURRENT MAILING ADDRESS TO GET YOUR SECURITY GUARD LICENSE WITHOUT ANY ISSUE. IT IS YOUR RESPONSIBILITY TO UPDATE YOUR MAILING ADDRESS. WE ARE NOT RESPONSIBLE IF YOU DO NOT GET YOUR SECURITY GUARD LICENSE (PHYSICAL CARD) IN THE MAIL. PLEASE FOLLOW UP WITH DEPARTMENT OF STATE BY CALLING 518 474 7569 FOR FURTHER INSTRUCTIONS.**
7. **In the event your security guard license application is pending or taking longer than usual time or got rejected by the Department of State, Division of licensing services, you will not receive a refund from LASI Security Company Inc or Department of State, Division of Licensing Services.**
